Matthew Heckles

Matthew Heckles was appointed as the Regional Administrator of HUD's Mid-Atlantic region in February 2022 and is responsible for the oversight and delivery of HUD programs and services throughout Delaware,

Maryland, Pennsylvania, Virginia, Washington, D.C. and West Virginia. He serves as HUD's liaison to elected officials, congressional delegations, city managers, stakeholders, and customers.

Prior to joining HUD, he served as the Assistant Secretary and Director of the Community Development Administration at the Maryland Department of Housing and Community Development. In this capacity, he oversaw a range of operations and services from the administration and financing of single-family mortgage and multifamily development financing to housing rehabilitation and local government infrastructure programs. Most recently, his efforts centered on COVID-19 relief programs that offered forbearance for small businesses as well as tenant and homeowner assistance. Matthew Heckles worked in various positions at the Delaware State Housing Authority for more than 12 years before his work in Maryland.



Steve Metraux

Stephen Metraux is Associate Professor and Director of the Center for Community Research and Service (CCRS) at the Biden School for Public Policy and Administration. Dr. Metraux has done extensive research on homelessness,

and associations between homeless and various services systems, including behavioral health, veterans, criminal justice and child welfare. His research uses administrative services data as a basis for understanding dynamics of multi-system

services use. Dr. Metraux has consulted widely with local jurisdictions and non-profits in providing policy-specific and localized solutions for providing homeless and other services more effectively and efficiently.

Prior to coming to UD he was an Analyst at the National Center for Homelessness Among Veterans at the US Department of Veterans Affairs, and Associate Professor of Health Policy at University of the Sciences.

He has worked on issues related to homelessness and housing nationwide, with extensive familiarity with these issues in Delaware and southeastern Pennsylvania, including Philadelphia.



Kevin L. Smith

For 26 years, Kevin L. Smith has served as CEO for Habitat for Humanity of New Castle County, seeking to build homes, community, and hope with hardworking families in New Castle County.

The first paid staff member hired by the New Castle County affiliate of Habitat for Humanity, he began his career with Habitat as a volunteer coordinator at Habitat for Humanity in Fresno, California.

He made his way out West—and to Habitat—through a Volunteer Program that is part of the Mennonite Church.

A Newark native and UD “Blue Hen,” Kevin previously worked in the systems field for Delaware companies such as AIG Marketing, Standard Chlorine, and Synerfac. He holds a B.S. from the University of Delaware in Business Management (Operations) and a minor in Management Information Systems. Kevin completed Habitat for Humanity's Leadership Certificate from Harvard Business School in 2010 and Bank of America's Neighborhood Builders Leadership Training in 2016.

Kevin is a bi-vocational minister, as he has recently been commissioned in the United Methodist Church

as a deacon (clergy-Reverend). Rev. Smith graduated in May 2022 with a Master of Arts in Ministry and Leadership from Lancaster Theological Seminary in Lancaster, PA. He will continue to serve Habitat for Humanity as his primary vocation and has added a secondary vocation as clergy for his church, Newark United Methodist Church.

Kevin and his wife Diane have been married for 23 years and are blessed with four daughters and two grandchildren.



Timothy Bailey

Timothy Bailey, originally from Omaha, Nebraska, currently serves as the Executive Director for Central Delaware Habitat for Humanity in Dover, Delaware.

Following a brief tour in the Army, Tim moved to Denver,

Colorado, in 1996 where he began his career in reprographics serving the architectural, engineering, and construction industry. He started as an entry level blueprint technician and in the first year took his first management position as a production supervisor. In 2003, Tim married his wife, Cynthia and started a family. In the following years, he continued to serve the Denver building industry as a production manager until 2010 when he accepted a position as general manager for a family owned reprographics company.

In 2014, Tim, his wife, and four children moved to the Delaware area to be near family. In 2017, Tim accepted a position as affiliate operations manager for Central Delaware Habitat for Humanity where he began work to provide affordable homeownership opportunities to individuals and families in Kent County, Delaware. Kevin Gilmore is the CEO of Sussex County Habitat for Humanity. Kevin has served with Habitat for Humanity since 1992. He started as a volunteer with his Campus Chapter at Elon University in North Carolina. After

college, Kevin worked with Habitat International at their headquarters in Americus, Georgia. From there he went on to serve with Habitat for four years in Guatemala.

In 2003, he completed a graduate student fellowship with Public Allies Delaware focusing on non-profit management and building volunteer programs. After earning his Master of Public Administration degree at the University of Delaware, Kevin came to work with Sussex County Habitat for Humanity in 2004 as their first paid employee. The organization now has 28 employees and five AmeriCorps members who work with over 2000 volunteers to carry out its mission.

Kevin has served nationally on the Habitat for Humanity International US Council and locally on the Board of La Esperanza in Georgetown. He currently serves on the Board of La Plaza Delaware and the Delaware Alliance for Nonprofit Advancement.
