### **Overview**

The Birth to Three Early Intervention Mediation and Facilitation Programs are statewide dispute resolution programs serving families with children receiving early intervention services in Delaware. When families and the early intervention program disagree, our staff may be able to help with one of two services:

- Early intervention mediation, where a trained mediator assists the parties to resolve specific conflicts regarding a child and family's early intervention services.
- Individualized Family Service Plan (IFSP) meeting facilitation, in which a trained facilitator assists the IFSP team in working together to develop an IFSP for the child and their family.

Our services are built on respect and self-determination, which nurture the relationship between the family and the early intervention program. We help all parties work together in a positive way to resolve disputes by creating conditions for constructive dialogue and collaborative decision-making.

Participating in Birth to Three Mediation and Facilitation services may not be used to delay or deny the right to a due process hearing or any other rights afforded to parents under the Individuals with Disabilities Education Act (IDEA) Part C.

# Birth to Three Early Intervention Facilitation Program IFSP Meeting Facilitation

### How does a facilitated meeting work?

- A facilitator will speak with both parties to listen to concerns, explain the facilitation process, and answer questions.
- If all parties are willing to participate, the facilitator will create an agenda for the meeting incorporating all concerns.
- During the meeting, the facilitator manages the meeting process so the team can focus on the needs of the child and family.
- 4. The participants control and create the outcome of the IFSP team meeting. The facilitator is impartial.
- If the meeting does not end in agreement, the parties may pursue other forms of resolution or exercise their procedural safeguards.

The facilitator is not a member of the IFSP team or an advocate for any person on the team.

The facilitator is an independent impartial person to the IFSP team meeting process.

### **About Mediation Services**

Mediation services are available to families participating in the early intervention program who want to resolve differences regarding their early intervention services.

### Mediation...

- · Is free, voluntary, and confidential.
- · Encourages dialogue.
- Ensures concerns are heard.
- · Finds common ground.
- · Rebuilds family and program relationships.
- Empowers participants to find a mutually agreeable solution.

In mediation, the participants determine the outcome, not the mediator.

### Birth to Three Early Intervention Mediation Program Mediation Services

### How does mediation work?

- A mediator will speak with both parties to listen to concerns, explain the mediation process, and answer questions.
- 2. If all parties are willing to participate, the mediator will coordinate a time and place for the mediation.
- The mediator guides the participants through a process that encourages open dialogue, helps clarify the issues, promotes understanding, and works to reach a mutually satisfying agreement that is in the best interest of the child and family.
- The participants control and create the outcome of the mediation, and the resolutions reached are documented in a mediation agreement, which is legally binding.
- If the participants do not reach a resolution, the participants may pursue other forms of resolution or exercise their procedural safeguards.
