## **Logan Herring**

Logan Herring is the CEO of The WRK Group (The Warehouse, REACH Riverside, and Kingswood Community Center) in northeast Wilmington.

Logan began his work in the Riverside neighborhood in 2016 as the Executive Director for Kingswood Community Center (KCC). He is now also leading REACH Riverside, (Redevelopment Education and Community Health), a non-profit community development corporation created to lead the \$250 million revitalization of the Riverside neighborhood following the Purpose Built Communities model. This will include 600 units of mixed-income housing and a new state of the art KCC.

REACH and KCC are working in partnership with The Warehouse. This is a co-working facility and network for teen-serving organizations designed to address violence, academic performance, and workforce readiness amongst youth in Wilmington. It provides them with access to more than 150 teen-focused program and service providers. More than 500 teens became members in its first year of operation, and 77 were employed in 2021.

In 2021, Logan was recognized as one of Delaware Online's Most Influential Delawareans, he was named CEO of the Year for Large Nonprofits by Delaware Business Times, and he was inducted into the Delaware Business Leaders Hall of Fame.



## **Carrie Casey**

Carrie Casey is the General Manager of the New Castle County Department of Community Services. The Department of Community Services provides a wide range of services to New Castle County residents and

visitors that will strengthen families and individuals, build social capital, improve neighborhoods, and ensure places and spaces to live, learn, play, socialize, and recreate.

Carrie is President of the Delaware Chapter of the National Association of Housing & Redevelopment Officials, serves on the Board of Directors of First State Community Action Agency, and is a Federal Home Loan Bank of Pittsburgh Housing Advisory Council member. She was instrumental in New Castle County's 2020 purchase of the former Wilmington Sheraton South Hotel and its conversion into the HOPE Center to assist people experiencing homelessness during the COVID-19 pandemic.

In 2021 Carrie received the Gerald E. Kandler Memorial Award from the ACLU of Delaware, which honors Delawareans who have demonstrated a lifelong commitment to fighting for civil liberties.



## Karen Speakman

Karen Speakman is the Executive Director of NCALL, the National Council on Agricultural Life and Labor Research. She has 42 years of experience in affordable housing and community development. Karen began

her career at NCALL as a Housing Specialist, was appointed Deputy Director in 1981, and became Executive Director in 2018. As Deputy Director she oversaw development of 46 rental housing complexes and the Restoring Central Dover initiative, as well as NCALL's Consumer Services line of business. Throughout her career, Karen has remained active in public policy advocacy at the federal and state levels regarding housing and community development.

NCALL's mission is strengthening communities through housing, lending, and education. NCALL is a Community Development Financial Institution (CDFI). It is also a HUD certified Housing Counseling agency and is considered an exemplary organization by NeighborWorks America®.

Karen is past President and a current Board member of the National Rural Housing Coalition, a member of the Delaware Affordable Housing Coalition, a member of the Delaware Racial Justice Collaborative, and has been President, a Board member, and the Housing Ambassador for 1993 for the Delaware Chapter of National Association of Housing and Redevelopment Officials.



## David Edgell, AICP

David Edgell is the Director of the Office of State Planning Coordination (OSPC). The mission of the OSPC is the continuous improvement of the coordination and the effectiveness of land use decisions made by state,

county, and municipal governments while building and maintaining a high quality of life in the State of Delaware.

Prior to his current role, David spent over eighteen years as a Principal Planner with the OSPC. As the "Circuit Rider Planner for Kent County" his primary responsibilities included coordinating and aligning State land use priorities and resources with County, municipal and development interests. Other responsibilities included the Downtown Development Districts program, the recent update of the Delaware Strategies for State Policies and Spending, and school site and facility planning. He has taken a leadership role in planning healthy communities, focusing on policies and actions aimed at reducing health inequities.

Prior to coming to the OSPC, David worked at the University of Delaware's Institute for Public Administration assisting small towns with planning, zoning, and governance issues. He began his career working for the City of Dover Department of Planning and Inspections.



#### **Katie Millard**

Katie Millard has been with Habitat for Humanity for over 10 years and is currently the Director of Development and Advocacy at Sussex County Habitat for Humanity. At

Sussex County Habitat Katie oversees all fundraising and advocates to increase access to safe, decent, and affordable housing in Sussex County and throughout the State of Delaware.

Over her career, Katie has made it her personal and professional mission to work for organizations that promote fair housing and access to affordable homes. Katie has secured nearly \$5 million dollars to build affordable housing in Sussex County and has advocated to increase funding for affordable housing production on the local and federal level. She previously worked at the Federal Home Loan Bank of Pittsburgh, Urban Redevelopment Authority of Pittsburgh, and Morris Habitat for Humanity. She is the Chair of the Sussex Housing Group's Advocacy Committee, sits on the Delaware Community Foundation's Grant Review Committee, is a member of the Delaware Affordable Housing Coalition, and was honored by Delaware Business Times in 2021 as a top 40 under 40 young professional in Delaware.



## **Bruce Wright**

With nearly thirty years of experience in leadership at one of Delaware's largest nonprofits, Anthony "Bruce" Wright brings a strong background in community

development, capacity building, and technical assistance, comprehensive community assessment, and strategic planning.

As Community Development Program Manager at First State Community Action Agency, Bruce leads a team working with close to two dozen marginalized communities across Delaware to build their capacity. Ensuring that underserved communities have the knowledge and tools they need to access resources and make informed decisions to improve their conditions is the core focus of his work. Bruce and his team have dedicated time and resources to ensuring that the causes and conditions of poverty in Delaware are being represented in decision-making circles that impact them. Advocacy for underserved communities is also a cornerstone of Bruce's work.

Bruce previously served as the Vice President of the Board of Directors of the Delaware Community Reinvestment Action Council, as the Chairperson of the Delaware Prevention Coalition, and on the board of Directors of Sussex County Habitat for Humanity.
